 - a) Site plan of the proposed premises. The plan should be drawn to scale and show full approach road net work to the premises, nearby land marks, and safety distances from nearest protected works.

NOTE :- In case, your application for temporary fireworks license is rejected:

- You have right to be heard by the licensing authority before rejection of such application.
- The licensing authority has to intimate you in writing and mention the ground of such rejection in the said letter.
- You have right to appeal before Joint Commissioner of Police of the concerned range in Delhi along with a fee of Rs. 200/- in cash or through demand draft.
- In case appeal is upheld by the appellate authority, the fee shall be refunded to you.
